Your decision is hardly a surprise since you told me you were omitting the bulk of the evidence supporting my allegations of usury, aka loan sharking, based on a whim, and that you were knowingly using the wrong formula to calculate percentage, rather than the proper formula for calculating interest, which serves only to fraudulently make the offence appear legal.

I will be exercising my right to file a complaint with the Office of the Independent Police Review Director. I will also be requesting an actual investigation by the more qualified and hopefully less “motivated” officers of the Financial Crimes Division of the Ontario Provincial Police.

Fortunately, I now have financing arranged for the production of our documentary, so I can afford to file a Private Information and obtain a copy of the recording of our conversation, during which I advised you that you were in error by calculating percentage instead of interest.

First, the South Simcoe Police Service ignored my complaint for a year, then your Detective Smith ignored me, the victim, and abided fully by the wishes of the accused, and now you have omitted huge parts of the crime and falsified calculations so you can claim there is not enough evidence to proceed with prosecution.

One reader of my page called the South Simcoe Police Service ‘Cops For Cash’. I cannot prove that, yet, but you certainly do know how to throw fuel on a journalist’s fire. Be assured, we will continue to report on this story while the untainted professional police review our evidence and the questionability of the various “investigations” undertaken by the South Simcoe Police Service.

Please provide me with the name of the person from the Crown Attorney's office who you claim reviewed the file, as I want to make sure they received everything I gave to you, before you changed the calculations and omitted the bulk of the evidence.

I hope you were compensated well for distraction from duty, and that you are not counting on trickle down from your superiors. After all, the widows and orphans have their needs.

I have not so far reached out to any of my counterparts in mainstream media, but given the transparent nature of this action I will now be sending a press release to the more than 200 contacts currently in my database.

Based on the facts and the evidence you have chosen to omit, change, and ignore, the South Simcoe Police Service is going to become known synonymously with criminal abuse of trust, helping loan sharks, and aiding to defraud seniors.

I hope you understand that this is not personal. You chose not to do your job, and somebody has to protect the seniors of Simcoe County. So, I will redouble my efforts to do mine by exposing the truth and the threat to their financial security.
